I, **Rosa PXXX** have personal knowledge of all facts set forth in this declaration and am competent to testify thereto if called upon to testify in a court of law. I hereby declare:

My name is **Rosa PXXX**, and I reside in Sacramento, Ca. You have my full name and address on file.

- I. I am a utility customer of SMUD since 1992 with a perfect payment record.
 - 1. I painted and sold my four-bedroom house and moved into the above address in July of 2010. I was enrolled at ARC American River College studying English, Italian and other courses.
 - 2. After moving in to my new apartment I began to notice that I did not feel well when inside. I felt much better while sitting in my car in the parking lot or doing errands. Some of the symptoms listed below started manifest but lack of ability to concentrate and think clearly was the first.
 - 3. There are twelve PG&E gas Smart Meters on my bedroom wall (10" from my head). They were there before I moved in. No one informed me that these Smart Meters were here: Nobody warned me before I moved in. See Picture Below.



4. In Nov. 2010 SMUD installed another thirteen Smart Meters (electric) on the same wall and I began to feel **much worse**. See picture below of actual meters.



- **5.** A man from SMUD phoned me to inform that the power would be off while they "Changed the Meter". I asked him if it was a *Smart Meter* and told him "I pray to God that it is not a *Smart Meter*". He responded that it "**No Ma'am, we are not installing Smart Meters"**. **He flat out lied to me on behalf of SMUD.**
- II. **My symptoms of Electro-Smog Sickness** got much worse when the SMUD Smart Meters were installed (Nov. 2010) including but not limited to the description below.
 - 1. **Headaches** at all times in apartment. Painkillers are required daily.
 - 2. **Insomnia** every night and worst in my bedroom by meters: I have to <u>sleep on floor in my living room</u> to reduce pain level associated with proximity to your Smart Meters.
 - 3. Horrible Nightmares every night.
 - 4. Intense Sweating at night.
 - 5. **Nose Bleeds** many times every day for up to two hours at a time: see my pile of bloody handkerchiefs in plastic bag.
 - 6. **Deep Stabbing Pain** inside my head and neck.
 - 7. **My Head** feels like it will explode.
 - 8. **Intense itchy rash** from scalp to toe requiring medicine.
 - 9. Welts on skin that leave scars.

- 10. Deep bronchial cough w/heavy flem.
- 11. **Dizziness'**, **weakness** and **unstable body control**. Sometimes I can only crawl around on the ground in my apartment.
- 12. Bloodshot and itchy eyes.
- 13. **Loss of Cognitive Ability.** I cannot do my class assignments or study for ARC anymore. I am losing my ability to think straight.
- 14. Mental Confusion.
- 15. Foggy thinking.
- 16. Hair Loss (major). Pink scalp.
- 17. Painful **leg cramps** at night.
- 18. Intensely dry mouth.
- 19. **Numerous doctor visits** that do nothing but prescribe pain medication. The Doctors cannot help me.
- 20. I believe have aged ten years in the last two years in this Smart Meter apartment.
 - I believe the Smart Meters are KILLING ME! I am losing my life. What life I have left is LIVING HELL every minute of every day due to your Smart Meters.
- 21. SMUD gave me NO CHOICE to refuse the Smart Meter even though it gave others (2500) a choice to Opt Out. You have deceived me.
- 22. I always feel much better away from my apartment after about twenty minutes!

SUMMARY & REQUEST for HELP:

I was raised in a country occupied by Nazis, Cossacks & Communist Dictators.

I came to America for freedom and this is not the America I came to love.

This tortuous punishment in my own private residence that I must pay for is far worse than I ever got from **Cossacks**, **Communists or the Nazis** before them.

What these Smart Meters are doing to me is beyond comprehension.

- 1. I demand that SMUD test my apartment for <u>ALL</u> potential electrical and radio transmission problems and provide me an official legally hand signed report in writing immediately!
- 2. If that does not solve the problem I want you to help me move to a SAFE PLACE away from your Smart Meters. I cannot live like this much longer.
