Ms. Tanner:

You would be well advised to re-read the instructions in the October 12th Agenda Notice prepared by PUCN employees.

Ιt

says in pertinent part: "Prepared comments or documentations may be introduced into the written record upon request." As Ms. DeFazio made the request of Ms. Cassity and I made the request of Ms. Osborne to include our written comments as exhibits to the Minutes/Agenda Notice at the meeting's end, there is no ambiguity that a request was made. Our requests followed the instructions stated at the beginning of the meeting that these two PUCN employees were to receive any written comments or other submissions. (FYI, the Commission should correct its error of using the non-existent word "documentations" to read "documentation" in any subsequent Agenda notices, which, as you may know, functions in both the singular and plural.)

As for

your incorrect assertion of the "large volume of public comment," there were just two public comments in Carson City and two public comments in Las Vegas at the October 12th from two total people. Given the thousands of pages of submissions filed with the PUCN each week , four pages of public comment to be included with the Agenda Notice/Minutes should not be overwhelming for PUCN staff.

Perhaps you missed this wording in NRS Section 241.035(1)(d): "The substance of remarks made by any member of the general public who addresses the public body if the member of the general public requests that the minutes reflect those remarks OR, IF THE MEMBER OF THE GENERAL PUBLIC HAS PREPARED WRITTEN REMARKS, A COPY OF THE PREPARED REMARKS IF THE MEMBER OF THE GENERAL PUBLIC SUBMITS A COPY FOR INCLUSION." As the statutory language in all caps clearly indicates, it is not necessary to even make a request for inclusion of written remarks as part of the public body's written minutes, just 'submit a copy for inclusion."

Thus, the legally prudent action is to include both commenters' October 12th's submitted comments in the usual and customary place, the Agenda Notice/Minutes as an exhibit. The General Public Comment file does not meet the NRS requirements the PUCN must follow.

Ms. DeFazio and I look forward to your rapid correction of these obvious errors by the
